PURPOSE OF FUNDRAISER		
THE PROGRAM There is a minimum order of 240 bags (6 cases) of cookies. Flavors must be ordered by the case (40 bags). To ensure the freshness of the product, the sale will run for a maximum of 4 weeks. The selling price of each bag of cookies is \$8.00. Your Organization will pay \$4.00 for each bag ordered. Your Organization will profit \$4.00 for each bag sold. Your Organization may not decrease the total number of bags once the order has been placed. Cookies will normally be ready for delivery or pick-up in 7-10 business days from the date of order. The Cookie Corner will contact your Organization once the cookies are ready for delivery or pick-up. The Cookie Corner will not take back unsold bags, nor will The Cookie Corner be responsible for lost or stolen bags. Both your Organization, and the individuals coordinating the fundraiser will be financially responsible to The Cookie Corner for all bags of cookies ordered.	PAYMENT Your Organization may choose to either pay up-front or follow The Cookie Corner's fundraiser payment schedule. Should your Organization choose to follow the payment schedule, they must, in addition to completing this Fundraiser General Contract, complete The Cookie Corner's Fundraiser Payment Schedule Agreement at a designated Cookie Corner location. The Payment Schedule Agreement must be signed by the same individuals as the General Contract. Each signer must present a valid credit card and form of photo identification. Payment #1 - 25% [Due 2 weeks after the start of sale] Payment #2 - 50% [Due 4 weeks after the start of sale] Payment #3 - 25% [Due 1 week after the end of sale] Yes, we will be following the payment up front.
